OVERVIEW




Internet access is a service for organizing technical access to the content services of the Moscow Exchange via the public Internet without the need for a special network scheme on the client side. The service provides the ability to connect from any place in the world via the Internet connection.

Since the Internet is not a guaranteed medium of data transmission, the stability of a VPN connection is inferior to connections over dedicated circuits. However, the service makes it easy to implement access reservation if there is more than one Internet connection.

Internet access is included in the list of services and software provided under an IT support agreement (ITO Agreement).

- MOEX services. The services of the Derivatives, Equity, Bond and FX markets are available via a VPN connection. The addresses of the Moscow Exchange services are published at https://www.moex.com/s397, and can also be provided upon request to the technical support service.

SUPPORTED HARDWARE

For remote access to the services of the Moscow Exchange using public Internet communication channels, no additional equipment is required except for the Client's PC

To work with the terminal, you need a computer with the following configuration:

NETWORK CONNECTIONS REQUIREMENTS

The bandwidth Client needs is the sum of the following values depending on the number of the services in use and the amount of FAST UDP Multicast feeds:

• 4 Mbit/s multiplied by the number of the gateways/terminals in use
